With reference to above mentioned matter the undersigned is directed to draw attention to OM No. S.11045/36/2012-CGHS (HEC) dated 01.10.2014 and further on 12.11.2014 vide which (i) Sadhu Vaswani Medical Centre, New Delhi – Diagnostic Centres, (ii) Sadhu Vaswani Medical Centre, New Delhi – Dental Clinic (iii) Sadhu Vaswani Medical Centre, New Delhi – Eye Centres (iv) Star Dental Centre, New Delhi (v) ASG Eye Hospital, Ghaziabad were empanelled under CGHS Delhi/ NCR and to state that all these Health Care Organizations have conveyed unwillingness to continue their empanelment under CGHS.
